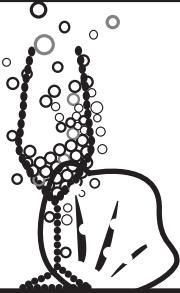

Event Bookings

A booking form needs to be completed and returned via fax, email or post for each event. One booking form for each member or guest. This is so we receive correct details for every person attending the event.

Once we have received your booking form and payment we take that as a confirmed booking. We will send you confirmation that we received your booking form within 48 hours of receipt.

By booking for an event, you are entering into a binding contract with Women in Balance and are liable for full payment of the event fee subject to the payment terms and cancellation/refund policy as detailed below.
